

I want to thank all the volunteers throughout my tenor on property committee and those who helped to get the parsonage ready for the pastors! The furnace in the basement education wing was replaced in April. Thanks to Dan Boy and Tim Patmore for fixing the railings on the front walkway. Thanks to a generous in-kind donation from Calvin Cammack and Greenscape our church lawn received special care throughout the summer. and they even cleared the leaves in the fall .Earlier in the summer they worked on the parsonage sprinkler system and blew it out in the fall. A leaky shower faucet was replaced in the parsonage and Al Weidenbach came up with a ceiling tile to replace the stained one in the basement. Following our plumber's recommendation for replacing the water softener and drinking filter at the parsonage, we have that project completed. Let me begin this report with a huge THANK YOU to the congregations and women's groups of the South Dakota Synod that have so generously supported their partnership ministry with Lutherans Outdoors in South Dakota. Through the end of December you have more than doubled your financial support for LO. In 2023, you provided just over \$87,000 to LO, now you have provided just over \$190,000. Thank you so very much for your financial support and for sending your families and children to experience a Christ centered community at Klein Ranch, Outlaw Ranch and NeSoDak, the three camps that you own.

When I started at the end of July, I could see in the financial report that we needed to raise \$850,000 before the end of the fiscal year, January 31, 2025. To date, your generosity has provided more than \$930,000. From gifts as small as \$5 to a gift totaling \$100,000, YOUR contributions have made all the difference in sustaining the ministry of LOSD. STAFF UPDATES

2024 has been a year of transition for Lutherans Outdoors in South Dakota. In March, Matt Rusch, our site Director at Outlaw tendered his resignation. Late April, Kaycee Cronin was hired to serve as site Director at Klein Ranch. At the end of July, Paul Hanson resigned as Executive Director, and Pastor David Zellmer was asked to serve as Interim Executive Director, Mara Stillson resigned as Marketing Director at the end of August. Linda Weidner retired from her role as Financial Officer for LO at the end of September and Randy Youngquist-Thurow completed his work as consultant to the Board at the end of October. November 1st Jamie Duprey began her ministry with LO as the new site Director of Outlaw Ranch. On December 2nd, Randy Olawsky and Ben Kyte, retired bankers, stepped in to share the Accounting role.

The Executive Director Search Committee began its work in November. They are hopeful that the LO Board will have the opportunity to meet with the candidate(s) this month.

She has created Pasque, named after our state flower, for every member of the South Dakota Synod to connect and learn with and from each other for free. Box Elder is one of the fastest-growing communities in South Dakota, and we are committed to showing up. Pastor Jonathan Vehar, the Synod's Director for Evangelical Mission, and Kathy McHenry, Executive Director of Lutheran Planned Generosity, are working diligently to build relationships with personnel from Ellsworth Air Force Base and the members of the Box Elder community. They continue to intentionally listen to the needs of the community and how to best partner in new and innovative ways to be the church for all people there. We always seek donors who help lay a sure foundation for this new mission to start in the beautiful Black Hills. Also, if you want to be a missionary but want to stay close to home, this is an opportunity to reach people in Christ's name here in South Dakota. Many of you have asked me if I would consider serving another term. I have shared with the Synod Council that I would be honored if the Synod would call me to serve a second term.
